At the 2021 meeting of MoP, it was agreed that the 2022 meetings of SERAWG, PEAWG, and Scientific Committee would be held as virtual meetings for SERAWG4 from 28 February to 4 March 2022, PAEWG4 from 7 to 11 March 2022, and the Scientific Committee (SC7) from 21 to 25 March 2022 (para 230, MoP8 report).
