Status of entry and exit reports received at the Secretariat

Abstract

CMM 2018/10 on monitoring requires CCPs to provide the Secretariat with every vessels entry to and exit from the Agreement Area.

The Secretariat collects all reports and merges them into a dedicated database.

A summary of notifications provided from July 2019 to August 2020 is provided in this document. Refer to the previous report (CC-03-Doc06) for the notifications received prior to this date.

Most of the reports are compliant I regard with the notification period; however, several discrepancies have been highlighted.

Recommendations

The Secretariat invites CCPs to help in clarifying some reports and to provide missing one.

Introduction

The Meeting of the Parties developed rules and procedures for the monitoring, control, and surveillance of fishing activities to ensure compliance with CMMs.

CMM 2019/10 describes the measures for the Monitoring of Fisheries in the Agreement. In 2018 a new paragraph about vessel entry and exit notifications was added:

Entry- Exit reports

14. Contracting Parties, CNPCs and PFEs shall require their vessels or relevant authorities to notify the Secretariat, by email or other means, within **24 hours**, in the format provided in Annex I, of each **entry to** or **exit from** the Agreement Area of vessels authorised to fish for species managed by SIOFA flying its flag, in accordance with CMM 2017/07.

The entry and exit notifications shall contains the following information in accordance with Annex I of CMM 2018/10 Monitoring.

Comoros has many over 24H notifications, where they are provided by the industry (vessel owner).

A problem known by Cook Islands is the reason why many reports have been provided much later than the actual vessels passages. Some reports that have been received from Cook Island are not relevant of SIOFA, the Secretariat do not need to receive these reports (e.g. Reunion-Mauritius ZEE crossing).

The Secretariat invite CCPs to resolve the issues above with the Secretariat.

Sometime, notifications for the same event are provided by 2 times by 2 different sources (Governmental and Industry). When the notifications are not the same (small variation of time and position) the Secretariat is not able to tell which one to keep.

Many entries or exits reports from France Territories are not on the SIOFA perimeter but occurs outside SIOFA and south of 45°S.

Conclusions and recommendations

When notifications are received, many are received within 24 hours and compliant in this regard.

Where issues have been recorded, the Secretariat invite CCP to resolve them so that all entry and exit reports are consistent over time.

The Secretariat reminds to use the proper annex format from CMM 2019/10 to provide the report to the Secretariat. It will also be helpful if latitude and longitude coordinates are provided in decimal degrees.

The Secretariat has not the capacity to check the relevance of the report at the time a report is received but it will try to alert the CCP when issues are detected.
