I am writing you this letter to invite you, on behalf of the Southern Indian Ocean Fisheries Agreement (SIOFA) Secretariat, to join our organization.

As a kind reminder, the SIOFA was signed in Rome the 7<sup>th</sup> July 2006 and entered into force in June 2012. Our Regional Fishing Management Organization (RFMO) has ten Contracting Parties to this date (Australia, China, the Cook Islands, the European Union, France on behalf of its Indian Ocean Territories, Japan, the Republic of Korea, Mauritius, the Seychelles, and Thailand), one Participating Fishing Entity (Chinese Taipei) and one Cooperating Non-Contracting Party (Comoros). Our objectives are to ensure the long-term conservation and sustainable use of the fishery resources in the Area, and to promote the sustainable development of fisheries in the Area. Since our first meeting of the parties in October 2013, we already adopted 15 Conservation and Monitoring Measures. We now meet on an annual basis to further develop our common management capacity over the Southern Indian Ocean high seas resources.

As a Contracting Party, you would be allowed to participate in decision-making on the exploitation of resources and the protection of ecosystems in SIOFA waters and would allow your vessels to be authorized to fish in SIOFA waters subject to compliance with the rules.
