### Abstract

In an email to HoDs dated 26<sup>th</sup> February 2019 I forward communication received from Mauritius regarding the Mauritius & Seychelles Joint Management Area that extends into the SIOFA Area and a copy the confirmation/response letter from the Secretariat (Annex I).

At the Fifth Meeting of the Parties which took place 25-29 June 2018 in Thailand, Mauritius reiterated its claim for historical rights on the Saya de Malha Bank and stated that the Secretariat would be informed of the progress on the legal evaluation undertaken by Mauritius (MoP5 Report, Para 781).

It is not understood if the communication received from Mauritius is the legal evaluation referred to at MoP5. A further response was provided by Mr Dr Badal 8 April 2019 (Annex II)

#### MAURITIUS-SEYCHELLES ESTABLISHED OF THE JOINT MANAGEMENT AREA

I have the honor to inform you that in March 2011, the United Nations Commission on the limits of the Continental Shelf conferred upon the Republic of Seychelles and the Republic of Mauritius an extended continental shelf covering an area of 396 000 km<sup>2</sup>. The two countries have subsequently signed two treaties in March 2012 establishing the joint exercise of their sovereign rights on and to sustainably manage the natural resources of that area.

2. The outer limits of the said extended continental shelf also known as the Mauritius-Seychelles Joint Management Area (JMA) are depicted in the attached map and have also been published in the Law of the Sea Bulletin No. 79 of 2013, pages 25-52.

3. The treaties also provide for the area to be managed by a Joint Commission comprising of officials from both countries.

4. It has come to the attention of the Joint Commission that in the publications of the Southern Indian Ocean Fisheries Agreement (SIOFA) Secretariat, the area under the management of the Joint Commission continues to be depicted as an area managed under SIOFA.

5. The Joint Commission would therefore highly appreciate it if the necessary steps could be taken to correctly depict the outer limits of the Mauritius-Seychelles Joint Management Area (JMA) in all future documents published the SIOFA and for a corrigendum to that effect to be issued with regard to publications made after March 2011.


