<b>Abstract</b>	
<p>This paper presents the SIOFA Fisheries Summary: toothfish (<i>Dissostichus spp.</i>, <i>D. eleginoides</i>, <i>D. mawsoni</i>) 2025.</p> <p>A template of the Fishery Summary type of document was first presented to and approved by SERAWG4 and SC7 in 2022, and it was adapted to this species as requested by SC7. The creation of this summary was recommended by the SC7, and a first draft was considered at SC8 but was not deemed ready for publication yet. This Summary was first endorsed by SC9 and MoP11 and published in 2024.</p> <p>The 2025 version of the SIOFA Fisheries Summary: toothfish includes updated figures using data up to 2023.</p> <p>Please note that this document contains sections with confidential data (highlighted in yellow) following a specific request of the SIOFA SC. These sections will not be included in the published version of this Summary.</p>

## Recommendations

The SIOFA Secretariat recommends that the SC10:

- **notes** the work done by the Secretariat in preparing the SIOFA Fisheries Summary: toothfish (*Dissostichus* spp., *D. eleginoides*, *D. mawsoni*) 2025.
- **notes** that some toothfish tagging data at the CCAMLR Secretariat had yet to be retrieved and could not be included in this analysis.
- **notes** that the Secretariat has added a section on toothfish tagging rates and overlap, as requested by SC9 in preparing the SIOFA Fisheries Summary: toothfish 2025.
- **notes** that the tag rate analysis has highlighted gaps in the data held by the Secretariat and **recommends** CCPs to submit the missing data to the Secretariat with their next data submission in 2025.
- **identifies** any elements in this summary that are confidential and should therefore be withheld from the published version.
- **provides** any comments or edits to the SIOFA Fisheries Summary: toothfish 2025 during the meeting.
- **considers** the frequency with which the Secretariat is to update the SIOFA Fisheries Summary: toothfish.
- **endorses** the SIOFA Fisheries Summary: toothfish 2025 and **recommends** that the SIOFA MoP tasks the Secretariat to publish it on the SIOFA website.
