Abstract	<p>According to paragraph 24 of CMM 2020-08, The competent authority of each Contracting Party, CNCP and PFE shall include at least the information set out in Annex IV in the written report of the results of each port inspection, which shall be forwarded to the competent authority of the inspected vessel and to the Secretariat.</p> <p>This document provides a summary of Port Inspections Reports (PIR) received at the Secretariat, for inspections made in 2022.</p> <p>The Rev2 of this paper updates the report with supplementary information provided by the flag state of one (1) vessel, and also updates the <i>end of inspection date</i> based on information that were included in the PIRs, but were not included in the original paper.</p> <p>The Rev2 also separates PIRs received from Non-CCP from the ones submitted by the CCPs.</p>
