Report on Port Inspections received by the Secretariat in 2023

Summary

Pursuant to paragraph 25 of the [Conservation and Management Measure establishing a Port Inspection Scheme](#) (CMM 08 (2020) (Port Inspection)), CCPs which have areas of national jurisdiction adjacent to the Agreement Area and that have ports within the coastal States, shall forward inspection reports to the Secretariat within 30 days following the date of completion of the inspection or as soon as possible where potential compliance issues have arisen or if there are issues which warrant the attention of the competent authority of the inspected vessel. The CMM also provides that if the inspection report cannot be transmitted within that time period, the port State shall notify the Secretariat within that same time period of the reasons for the delay and when the report will be submitted.

A total of 48 inspection reports was submitted to the Secretariat in 2023. These inspection report includes 19 inspection reports that was received from a Non-CCP. Of the 29 reports received from CCPs, one (1) of them was submitted after the 30 day deadline, and none of the CCPs notified the Secretariat of the delayed reports, prior to the end of the mandated deadline.

None of the reports submitted highlighted potential compliance issues identified during Port Inspections. However one of the reports prompted the Secretariat to conduct a follow up with the port state as the report indicated potential fishing by a vessel flagged to a non-CCP within the Agreement Area. However, with additional provided by the Port State, it was confirmed that the vessel did not operate within the Agreement Area, but within an EEZ which is adjacent to the Agreement Area and it was authorized to operate.
