- 1. Circular 2023/01 (Date: 3rd January 2023)
 - Announcement of potential solution for new premises in Le Port, requiring major renovation works.
 - Steps taken to secure the usufruct of the house free of charge from the French government.
 - o Letter sent to France (Overseas Territories) to seek funding for renovations.
 - o Response received from the Director General of Maritime Affairs, Fisheries, and Aquaculture, indicating France's intention to provide a voluntary contribution of €175,000.
 - o Expected commencement of renovation work upon receipt of funds.
 - o Objective set to inaugurate the new Secretariat headquarters in July 2023.
 - Mention of the need to amend memorandum of understanding with the Government of the French Republic to provide office accommodation and related services.
- 2. Circular 2023/06 (Date: 2nd March 2023)
 - o Confirmation that all CCPs have approved the new premises project.
 - o Appreciation expressed for their support.
 - Construction work underway, funded by the generous contribution from the French government.
 - o Drafting of a new Memorandum of understanding with the Government of the French Republic in collaboration with French authorities.

3. Situation on June 19, 2023:

- Due to adverse weather conditions in March, the renovation work on Réunion has experienced a slight delay. However, we are pleased to announce that it will now be completed by July 15, 2023.
- Certain finishing work, particularly on the exterior, is still pending and is expected to be finalized by July 22, 2023.
- The relocation of the SIOFA Secretariat from Saint Denis to Le Port is scheduled to take place by the end of July 2023.
- The Secretariat has duly informed the French authorities about our impending move, and the inspection of our current premises is planned to be conducted at the beginning of August 2023.
- o The official inauguration of the new Secretariat headquarters is planned to be held between September 5 and 8, 2023. Please note that the exact date is yet to be confirmed.
