Review of Recommendations of the 10th Meeting of the Parties (MoP10) on the SIOFA Final SIOFA Compliance Report (fSCR)

Summary

Paragraph 5 of the [Conservation and Management Measure for the Establishment of a Southern Indian Ocean Fisheries Agreement \(SIOFA\) Compliance Monitoring Scheme](#) requires that the Compliance Committee and the Meeting of the Parties reviews any other recommendations made by the Meeting of the Parties in previous years' Final Compliance Reports (fSCR) in order to verify how those recommendations have been implemented by the concerned CCPs, the Compliance Committee or the Meeting of the Parties, as applicable, including in relation to follow-up actions.

The 10th Meeting of the Parties endorsed one recommendation from the fSCR, which is to improve clarity on the applicability of Paragraph 4 & 5³ of the [Conservation and Management Measure for the Monitoring of Fisheries in the Agreement Area \(Monitoring\)](#), i.e. to clarify that it is only applicable to vessels on the SIOFA Record of Authorized Vessels (RAV).

There were no other follow up actions required by CCPs with identified compliance issues.

Table 1 below shows a summary of the recommendation and its status, at the time of drafting this paper.

CC agreed that the obligation of Paragraph 5 & 6 of CMM 10 (2023)(Monitoring) should apply to vessels on the SIOFA RAV only, with a proposal to amend the CMM to provide this clarity.	CCPs/ MoP	Not Started
