Abstract				
The MoP TASKED the Secretariat to prepare a paper describing the data required to be collected				

The MoP TASKED the Secretariat to prepare a paper describing the data required to be collected by CCPs, the data required to be reported to the Secretariat, and the differences between the two types of data.

Data collection and data submission requirements are defined in SIOFA CMMs. Fishery data and MCS data are the two main type of data CCPs must collect and provide. SEC-2021-05 consultancies highlighted that CMM 02 on Data Standards do not distinguish between data to be collected and data to be submitted and recommended that data collection requirements would be separated from CMM 02 to increase flexibility when the SC requires that a new data item is collected.

#### Recommendations

- The MoP to note that the data to be collected and the data to be reported is usually the same.
- The MoP to advise if the data collection requirement and the data submission requirements set in CMM 02 should remain together in CMM 02, or if the data collection requirements shall be set outside CMM 02.

# Data Required to be collected by CCPs vs Data Required to be submitted by CCPs

## 1. Introduction and rationale

At its 11<sup>th</sup> meeting, the MoP tasked the Secretariat to prepare a paper describing the data required to be collected by CCPs, the data required to be reported to the Secretariat, and the differences between the two types of data (ref MoP11 report, paragraph 194).

This request stemmed from one recommendation of the data audits that advised that data submission requirements and data collection are distinguished (ref report of project SEC-2021-05 and MoP-11-16 Data and Security audits implementation update, recommendation D4). The objective is that the collection requirements (and protocols) are set outside CMM 02. This will avoid the MoP to consider and adopt the CMM 02 every time the SC needs to amend the data collection requirement.

The Secretariat took this opportunity to recap which data must be collected by CCPs and which needs to be submitted to the Secretariat.

### 2. Method

Data or notifications relevant to structured data listed within SIOFA CMMs have been summarized in the next section.

## 3. Conclusion

Most data that need to be collected by CCPs is the same that must be submitted to the Secretariat.

Regarding Catch and Effort and Observer data, separating the data collection and the data submission requirements in CMM 02 would improve the flexibility and efficiency when the SC provides recommendations on data to be collected (and how the collection should be undertaken). If the data collection requirements were set outside the CMM, there would not be a need to amend

and the MoP to adopt the CMM changes every time the data collection needs change. Currently the data item to be collected are provided in the annexes of CMM 02.

A few data item are requested to be collected and submitted by 2 different CMMs but on a different periodicity.

Regarding MCS data, the requirements are well defined. The implementation of a SIOFA VMS would merge data collection and data submission requirements.
