# SC- CIRCULAR n° 2022/19-Rev1

#### SUBJECT: Intersessional Workshop the development of ecosystem and fisheries summaries (WS2022-SUM1)

Dear Heads of Delegation of the Scientific Committee,

Dear Colleagues,

As requested by SC7 and MoP8, the SIOFA Secretariat has been drafting Ecosystem and Fisheries Summary Reports (para 43 & 44 of MoP8 (2022)):

- 43. The SC ENDORSED the SERAWG's request that the Secretariat and the SC Chair work in consultation with CCPs over the intersessional period to further develop the fishery report template and present draft fisheries summaries at SERAWG5, with particular emphasis on toothfish, alfonsino, orange roughy, oilfish (Ruvettus pretiosus (OIL) and Lepidocybium flavobrunneum (LEC)), Nemadactylus macropterus (TAK), Polyprion americanus (WRF) and Polyprion oxygeneios (WHA).
- 44. The SC ENDORSED the Protected Areas and Ecosystems Working Group's (PAEWG's) request that the Secretariat and the SC Chair work in consultation with CCPs over the intersessional period to further develop the ecosystem report template and present a draft ecosystem summary at PAEWG5.

To progress the arrangements for the Intersessional Workshop the Development of Ecosystem and Fisheries Summaries (WS2022-SUM1), the Chair and vice-Chair of the Scientific Committee have proposed an agenda and timetable, which was revised according to the feedback received from CCPs. Outcomes from the workshop would be a report to be considered by the Scientific Committee at SC8 in March 2023.

Discussion on the content and format of the proposed Ecosystem and Fisheries Summary reports will be carried out in a focused workshop held over two days on Tuesday 27th-4th September-October and Tuesday 6th December 2022.

We invite all Scientific Committee HoDs to provide any suggestions or comments on the proposed meeting objectives, agenda, or timetable for the workshop to the SIOFA Science Officer (marco.milardi@siofa.org) on behalf of the Scientific Committee Chair with any comments by <u>20-27</u> September 2022.

- 6. Discussions will be held under Chatham House rules (i.e., presentations, papers, and individual comments would not be attributed). No meeting notes are to be distributed, but SC HoDs comments on the draft Ecosystem and Fisheries Summary reports will be addressed in revised versions.

7. Final drafts of the Ecosystem and Fisheries Summary reports will be submitted to SC8 for consideration by the Scientific Committee.
