# Provisional Meeting Arrangements, Terms of Reference, Agenda and Timetable for the Third Joint MoP-SC Workshop on the Development of Harvest Strategies (WS2025-HSS)

## 1. Introduction

At its 12<sup>th</sup> Meeting of Parties in 2025 (MoP12, paragraph 196), SIOFA agreed to hold a third Workshops on the Development of Harvest Strategies. The first workshop (<u>WS2023-HSMO</u>) was held virtually on 7–8<sup>th</sup> November 2023, and the second was held on 29<sup>th</sup> June 2024 (<u>WS2024-HSS</u>) in hybrid format.

This SC Circular outlines the proposed terms of reference, the provisional agenda, and meeting arrangements for <u>WS2024-HSS</u>. The outcomes of the workshop will be presented to the 2026 annual meeting of the Meeting of Parties (MoP13) and to the 2026 annual meeting of the Scientific Committee (SC11).

## 2. Meeting arrangements

The meeting arrangements are:

- 1. That the meeting be open to all Delegations to the Meeting of Parties (MoP), including representatives of the Scientific Committee (SC) and SIOFA Observers.
- 2. That the workshop be co-convened by the Chairs of the MoP and the SC.
- 3. That the workshop meets in virtual format on **Wednesday 17 December 2025 from 08.00 UTC to 12.00 UTC**.
- 4. That a report of the workshop be compiled by the Workshop rapporteur and the Conveners. The draft report will be circulated to participants with any comments to be addressed by the Conveners in time for it to be presented to the 2026 meetings of the SC and MoP.

  - c. Development of Harvest Strategies (<a href="https://siofa.org/science/sc-works/PAM-2024-03">https://siofa.org/science/sc-works/PAM-2024-03</a>).

- 3. Provide advice for the SC and MoP on any aspects of a future work plan for the development of a precautionary approach and the management of SIOFA stocks.
