This document presents first an explanation item-by-item of the expenses done and the expenses planned until the end of the year, and in the annex a table presenting the Budget adopted by MoP8, the expenses done until the 30th of June, the expenses already planned until the 31st of December 2022, and the potential remaining funds.

### **SIOFA DRAFT MIDYEAR BUDGET 2022**

In accordance with the requirement of the MoP 8, this paper provides a Draft Midyear Tracking Budget, from the 1<sup>st</sup> of January 2022 until the 30<sup>th</sup> of June 2022.

This mid-year draft tracking budget has been realized in collaboration with the accountancy firm Crowe Horwath which was contracted to help with accounting and bookkeeping throughout the six first months of the year 2022.

#### **FINANCIAL RESOURCES AT MID YEAR 2022**

This report provides the Meeting of the Parties with an overview of the budget position and contributions as of the 30<sup>th</sup> of June 2022.

SIOFA is currently in a favourable financial position due to savings made on previous years' budgets and the receipt of voluntary contributions.

Section 1 provides an overview of the budget position of different SIOFA accounts. The financial position of each account and sub-account are detailed in the ensuing sections.

#### 1. SIOFA General Account and Sub Accounts

Table 1 provides the status of SIOFA General Account and sub-accounts.

The contributions provided by the European Union are made via an invitation to apply for specific funding aimed to support SIOFA actions related to scientific advice, including conservation status of key SIOFA species and management of exploited stocks, as well as the organization the next meeting of the Scientific Committee. The EU contributes to a maximum of 80% of total eligible project costs for each project. The remaining 20 % of the project costs are Secretariat staff costs.

#### Details of transfers between budget items

According to Financial Regulation 4.3, the Executive Secretary may authorize the transfer of up to 10 per cent of appropriations between sub-items of an item. The Chairperson may authorize the Executive Secretary to make transfers between sub-items of an item above this limit. The Chairperson may authorize the Executive Secretary to make transfers of up to 10 percent of appropriations between items.

01<sup>st</sup> January 2022 – 15<sup>th</sup> May 2022: Due to higher expenses than expected for both the 6<sup>th</sup> Compliance Committee and 9<sup>th</sup> Meeting of the Parties in hybrid format, some transfers between items and sub-items have been required, all of which have been authorized by the Chairperson.

These expenses didn't exceed the budget adopted by the MoP8 dedicated to the Item 4.

The EU Grant system requires that finalized reports be submitted before the balance of the grant can be received. Provided that the finalized reports are satisfactory, SIOFA should receive by the end of 2022, the pending funds of 23 514 € corresponding to the balance of the EU Grant n° SI2.815850 then in 2023, 60 000 € corresponding to the balance of the EU Grant n° SI2.837681. That will allow to the SIOFA Scientific Research Account to dispose of a remained fund of [(60 000€+23 514€)-50 346€]= **33 168**€

#### 1.3 SIOFA Reserve Fund

The emergency/contingency funds of the 2017-2020 budgets plus unspent budgets from 2016 to 2020 were used to build up a reserve fund in order to maintain a financial level sufficient to finance operations during the first 3 months of the financial year, plus 10% of the annual budget for the current year financial year for use in the event of an emergency. The amount of the reserve funds on 31st December 2021 was 434 493 €.

Following decision from the MoP8 (para 192 and Annex O), the expenses linked with separation from service of the Data Manager, the recruitment process of a new Science Officer of the SIOFA and the audits on Data and Physical securities have been funded directly from the SIOFA Reserve Fund during the year 2022. These movements on this account are detailed in the Table 7 below.

Furthermore, there is currently 49 892 € in unspent 2021 budget funds in the general account.

In accordance with SIOFA Financial Regulation 4.2 appropriations can remain available for up to 12 months following the end of the financial year to which they relate. For this reason, unspent 2021 budget funds will only be paid into the SIOFA Reserve fund at the end of 2022. The same process could be done with the budget 2022 for 2023. This practice also ensures sufficient funds remain available within the general account, ensuring continuity of daily SIOFA business by providing a buffer against late payments of annual contributions.


#### Mid-Year Budget 2022
